Roll call vote: Trustee Kevin Stienstra-yes, Josh Kearney-yes, Francis Temperly-yes, Sarah Saylor-yes, Bill Wiegman-yes, and Robert Hessling-yes and President Dale Leifker-yes. Motion carried 7-0.

**REPORTS OF VILLAGE OFFICERS:**

**DIRECTOR OF PUBLIC WORKS REPORT:**

~ The need has arose to look at the water main on 21<sup>st</sup> Street. This is the third (3<sup>rd</sup>) patch in 6 months and the second (2<sup>nd</sup>) in 24 hours. We will need to look at replacement options.

~ In the process of setting up a pre-construction meeting with the engineer and the contractors for the N Main Street Project.

~ A street committee meeting will also be scheduled.

**UNFINISHED BUSINESS:**

**INTERSECTION OF N MAIN ST & HWY 11/80- LEAVE PLANS AS IS OR MOVE INTERSECTION APPROXIMATELY 60 FEET SOUTH, INTO 2435 N MAIN STREET , COMMONLY REFERRED TO AS THE ‘Y’ PARK:** The Village Engineer, Keith Dalsing, had drawn up specs showing the intersection at North Main Street and Hwy 11/80 and moving the intersection approximately 60 feet south by utilizing land from the 2435 N Main Street, commonly referred to as the ‘Y’ Park or Point Park.

Trustee Bill Wiegman made the motion to rescind the motion from the March 3, 2015 meeting to approve the plans that were presented at that meeting. Trustee Josh Kearney seconded the motion. Roll call vote: Kevin Stienstra-yes, Josh Kearney-yes, Francis Temperly-yes, Sarah Saylor-yes, Bill Wiegman-yes, and Robert Hessling-abstain and President Dale Leifker-yes. Motion carried 6-0-1.

President Dale Leifker made the motion to approve the plan to utilize land at 2435 N Main St, (‘Y’ Park or Point Park) to move the intersection of North Main Street and Hwy 11/80 approximately 60 feet to the south of where it currently is. Trustee Bill Wiegman seconded the motion. Roll call vote: Kevin Stienstra-yes, Josh Kearney-yes, Francis Temperly-yes, Sarah Saylor-yes, Bill Wiegman-yes, and Robert Hessling-abstain and President Dale Leifker-yes. Motion carried 6-0-1.

Mike Lovell stated that on behalf of the church, he would like to thank the Board for all that they have done on this issue.

President Dale Leifker stated that changing of the intersection was done as a safety issue and the Village Board has an obligation to the tax payers and to people who use the road to make it safe. It was nothing personal with St. Francis de Sales and he was disappointed in comments that were made about the Village Board and the employees that stated otherwise.

**CLARIFICATION ON ADDITIONAL RESTRICTIONS FOR C-1A DISTRICT:** When discussion was held on dwellings on the first floor, the information they were given was for the C-1A district and not for the C-1 district that was discussed.

Dwellings are not allowed on the first floor of the C-1 district and dwellings are permitted below the second floor for the C-1A district.

**NEW BUSINESS:**

**RECOMMENDATION ON CREATING AN ORDINANCE TO RESTRICT PARKING OF CERTAIN VEHICLES (BOATS, CAMPERS, ETC.) ON THE STREETS:**

This matter was discussed at the Law Enforcement meeting prior to this meeting and the committee made the recommendation to accept an ordinance to restrict certain vehicles from being parked on the street.

President Dale Leifker made the motion to accept the following ordinance:

***Street parking.*** No person owning or having control of any truck, trailer, truck power unit, tractor, bus or recreation vehicle in excess of 12,000 pounds licensed vehicle weight, or over 24 feet in length, or having an enclosed area of height of more than eight feet from the roadway, shall park the same upon any street, avenue or public right-of-way in the Village zoned residential or adjacent to residential areas. The provisions of this subsection shall not be deemed to prohibit the lawful parking of such equipment upon any street, avenue or public way in the Village for construction, building, landscaping or related purposes, or for the actual loading or unloading of goods, ware or merchandise; providing, however, the uses as described in this section shall be limited to the actual time consumed in such operations or while such operations continue.

*Boats, boat trailers, animal trailers, snowmobiles, snowmobile trailers, and other unmotorized trailers, or off-road motor vehicles shall not be parked upon any street, avenue, or public right-of-way.*

***Removal.*** Any vehicle unlawfully parked under Subsections A and B above, may be removed from the street by order of a law enforcement officer, pursuant to § 320-20, and the expense of so moving and storing such vehicle shall be paid by the operator or owner of said vehicle as a forfeiture in addition to the penalties hereafter prescribed. The Police Department may issue temporary permits for parking the above-mentioned vehicles not to exceed 48 hours.

Trustee Sarah Saylor seconded the motion. Roll call vote: Kevin Stienstra-yes, Josh Kearney-yes, Francis Temperly-yes, Sarah Saylor-yes, Bill Wiegman-yes, and Robert Hessling-yes and President Dale Leifker-yes. Motion carried 7-0.
