DISCUSS AND POSSIBLY RESCIND THE MOTION FROM THE
SEPTEMBER 15, 2015 MEETING FOR THE PAY REQUEST FOR OWEN'S
EXCAVATING FOR WORK ON THE N MAIN ST PROJECT (PAYING
CONTRACTOR ONCE STATE FUNDS ARE RECEIVED): Clerk Sally Bauer
informed the board that it was explained to all of the contractors during the bidding
process and at the pre-construction meeting that this was a federally funded grant and
that payrolls and pay requests had to be submitted timely to ensure that payment was
received timely.

With our first pay request from Owen's Excavating, the state has asked for additional information from the Village. They requested a copy of all invoices and check stubs that pertained to the Village's match portion of the project. In speaking with Village Engineer, Keith Dalsing, even though all contractors were informed about the grant, Owen's Excavating's contract is with the Village and the Village has the contract with the state for the funding of the project.

The motion that was discussed is from the September 15, 2015 meeting: Trustee Bill Wiegman made the motion to grant the pay request to Owen's Excavating & Trenching LLC for \$184,913.70. President Dale Leifker seconded the motion. Roll call vote: Josh Kearney-yes, Francis Temperly-yes, Becky Lee-yes, Bill Wiegman-yes, Robert Hessling-yes and Dale Leifker-yes. Motion carried 6-0. It was clarified that the payment to Owen's Excavating & Trenching will be made after the money is received from the state.
