# **DIRECTOR OF PUBLIC WORKS REPORT, JOHN BERNING:**

The Board had asked John to look into the following:

- ~Replacing the current street lights with LED lights would cost approximately \$14,000.00. This for the 45 lights that line Hwy 80 north & south and Fairplay Street east & west.
- ~ To replace the street lights, poles and flash collars for South Main Street would cost around \$4,000.00, 6 foot sidewalks would be about \$50,000.00. Underground electric would be done also. There is also the possibility of replacing the watermain from Fairplay St to 19<sup>th</sup> Street.
- ~There will be two (2) wide loads coming through town on Saturday, December 19. Wires will have to be raised to accommodate this as the load is 20 feet high. All time that village employees work to accommodate this load will be billed to the company.

- ~ Four (4) sections of fence have been removed from the N Y Park to make for a better vision triangle at the intersection of N Main St and Percival.
- ~ Repairs are needed at the sewer plant. Two (2) submersible pumps are needed along with two (2) pump stands. The totalizer also looks like it was struck by lightning, we are looking into filing an insurance claim for the totalizer. All of the needed maintenance/repairs will total \$12,000.00 15,000.00. A quote should be received by the next meeting.
