

**HAZEL GREEN SPECIAL BOARD MEETING
MARCH 29, 2016**

Clerk Sally Bauer called the meeting to order at 7:00 p.m. Proof of publication: notices were posted at American Bank, Post Office, Village Hall, the Village website and all the Trustees were notified via email of the agenda.

Trustee Francis Temperly made the motion to put Trustee Kevin Stienstra in charge of the meeting. Trustee Becky Lee second the motion. Roll call vote: Kevin Stienstra-abstain, Josh Kearney-yes, Francis Temperly-yes, Becky Lee-yes and Robert Hessling-yes. Motion carried 4-0-1.

MINUTES OF PREVIOUS MEETINGS: Trustee Josh Kearney made the motion to approve the minutes from March 15th as presented. Trustee Becky Lee seconded the motion. Roll call vote: Josh Kearney-yes, Francis Temperly-yes, Becky Lee-yes, Robert Hessling-yes and Kevin Stienstra-yes. Motion carried 5-0.

COMMUNICATIONS:

CLERK: The office is working on election materials and training election workers, finishing up the PSC audit and beginning gathering information for the electrical rate case.

GCEDC: Robert Hessling and Bill Wiegman attended this meeting in Cassville. A tour was held at Stonefield Village and a meeting followed.

REPORTS OF VILLAGE OFFICERS:

DIRECTOR OF PUBLIC WORKS REPORT, JOHN BERNING:

- ~ A sewer valve went bad at the main lift station, it was repaired.
- ~ Dirt work on N Main Street will begin once the ground dries more.
- ~ Street signs are set to be installed.

STREETS COMMITTEE MEETING REPORT:

- ~ The following streets were looked at for slurry: Freiburger Lane, Oak St from Hwy 11 to 21st Street, and 21st street from Oak St to Hwy 11/80.
- ~ Prices will also be obtained for 18th St from Birch St to Main St and S Main St to be sprayed.

UNFINISHED BUSINESS:

CONSTRUCTION FOR SOUTH MAIN STREET PROJECT – SIDEWALKS, CURB & GUTTER, UNDERGROUND ELECTRICAL INCLUDING NEW POLES AND LIGHTS, MILLING STREET, WATERMAIN REPAIR FROM CTY W TO 19TH STREET: Discussion was held as to what projects, if any, should be done this year. Discussion was also held on the new business agenda item as it possibly coincides with project work to be done.

PRICES FOR VISU-SEWER TO TELEWISE SEWER MAINS AND LATERALS. POSSIBLY RESCIND MOTION FROM 11/17/2015 (TELEVISIONING THE SEWER IN PARTS OF SUNSHINE ACRES AND SOUTH MAIN ST): It was talked about this if we were going to televise S Main St and possibly mill the street, to also televise the laterals on S Main St while we were televising the sewer main. Trustee Francis Temperly made the motion to rescind the motion from November 17, 2015 regarding televising parts of Sunshine Acres and S Main St. *President Dale Leifker made the motion to televise 4,130 linear feet of sewer main at \$1.91/linear foot. Trustee Bill Wiegman seconded the motion. Roll call vote: Kevin Stienstra-yes, Josh Kearney-yes, Francis Temperly-yes, Bill Wiegman-yes, Robert Hessling-yes and Dale Leifker-yes. Motion carried 6-0.* Trustee Josh Kearney seconded the motion. Roll call vote: Josh Kearney-yes, Francis Temperly-yes, Becky Lee-abstain, Robert Hessling-yes and Kevin Stienstra-yes. Motion carried 4-0-1.

Further discussion was held on the what sewer mains to televise. Trustee Becky Lee made the motion to televise 22nd & 23rd Street from Oak St to Pine St, Oak St from 22nd St to 23rd St and Pine St from 22nd St to 23rd St and S Main St from Cty W to Hwy 80 for 4,130 linear feet for \$1.91/linear foot. Trustee Francis Temperly seconded the motion. Roll call vote: Josh Kearney-no, Francis Temperly-yes, Becky Lee-yes, Robert Hessling-yes and Kevin Stienstra-no. Motion carried 3-2. No laterals will be televised.
