**DIRECTOR OF PUBLIC WORKS REPORT, JOHN BERNING:**

- ~ The sewer at 16<sup>th</sup> & Main St will be done this week, weather permitting, to remove the cement that is in the main.
- ~ Slurry is set to be done the 2<sup>nd</sup> week of July.
- ~ There are seven (7) underground electrical services that need to be installed. Also, nine (9) lots in Woodland Park subdivision have been sold. We will need to provide service to them as well.

A quote was obtained from Wolter Power Systems for a lift station generator of \$15,734.21. This price does not include installation, the concrete pad for it to sit on, Alliant will have to install a natural gas line or a multi-tap.
