### **COMMUNICATIONS:**

<u>**UPDATE ON SHED:**</u> A group of volunteers worked on the new shed on Saturday to frame the building up.

**LION'S CLUB PROJECTS FOR REC PARK:** Jake Riniker presented the committee with some ideas for a PA system for the park. The estimate is for this system is around \$1,100.00. A wireless system was not inquired about but a quote will be requested for it.

The gazebo was discussed. The Village will buy the paint/stain for the Leo's to paint/stain it. We will also inspect it to see if it needs to be pressure washed before it is painted/stained.

A new entrance sign was discussed. Sue Bennett stated that the entrance sign that is there now was donated by Dan Smith's parents. She asked if it could be relocated in the park. She also asked if a sign painted by Jodi Splinter that was on the old shed could be relocated in the park as well.

### **REVIEW SUMMER REC PROGRAM WITH SOUTHWESTERN SCHOOLS:** The

following agreement was discussed:

### SOUTHWESTERN SCHOOLS RESPONSIBILITIES

- Helps with registration for summer rec
- Pays for coaches
- Pays for rec directors potential split into 4 areas Girls, Boys, Soccer, Apparel
- Pays for umpires for softball and baseball games
- Pays for referees for soccer
- Each area (soccer, baseball, softball) is responsible to schedules their own games and umpires
- Is responsible for Apparel that is being sold to community (cost is offset by selling) Any profits will be deposited into fund 80.
- Pays for apparel for sports teams (fee is charged to offset this cost)

# **BENEFITS**

- Success of the HG Summer Rec will help build a stronger program for the high school and better connection to the School District
- Create a stronger relationship with the village/community and school
- With the collaboration of the Village, this helps the school build a stronger sports foundation.

# VILLAGE OF HAZEL GREEN RESPONSIBILITIES

- Work with School to set up and run registration
- Pays for all equipment needed for summer rec programs
- Pays for weekend tournament fees and end of year tournament fee
- Responsible for regular duties of cutting grass and maintenance of the fields
- *Responsible for grooming and marking the fields*
- Pays for concession stand employees
- Village will sell off their current apparel at the park for a discount

# <u>BENEFITS</u>

- Success of the HG Summer Rec program will bring added revenue to the park and Village businesses
- With the collaboration of the school, this saves the Village from added work involved with managing the HG Summer Rec program.
- Monies from rec park registration will help to offset costs for maintenance of the Park
- Monies from the concession stand purchases, not including the apparel sale of new HG Rec inventory, will help offset costs of concession stand employee and inventory

\* The Village of Hazel Green and School District of Southwestern agree to revisit these responsibilities no later than the end of March of every year.
